

TOWNSHIP OF ROSTRAVER

REORGANIZATION MEETING

January 7, 2008

The Reorganizational Meeting of the Rostraver Township Board of Commissioners was called to order on this date by Secretary, Pamela S Beard at 6:00 p.m. in the Rostraver Township Municipal Building

Secretary Beard requested that newly elected Township Commissioners – Ralph Jacoboni, Nick Lorenzo and Brian Sokol to step forward to take the Oath of Office.

Secretary Beard continued that it was her privilege and extreme pleasure to introduce the Honorable Charles Christner, District Justice, Magisterial District No 10-2-06, who administered the Loyalty and Oaths of Office to the newly elected Commissioners Ralph Jacoboni, Nick Lorenzo and Brian L. Sokol.

Swearing in ceremonies continued followed by the Reorganization Meeting.

Secretary Beard served as Temporary Chairman for the reorganization

MOTIONS:

Temporary Chairman Beard declared nominations for the office of President/Chairman of the Board of Commissioners for a two year term were in order

Thomas G Patterson nominated Nick Lorenzo for President/Chairman for a two year term Brian L. Sokol seconded the nomination.

There being no further nominations, Temporary Chairman Beard declared nominations for this office of President/Chairman closed.

Being there was only one nominee, Secretary Beard declared a unanimous ballot for Nick Lorenzo as President/Chairman of the Board of Commissioners.

Temporary Chairman Beard declared nominations for the office of Vice President/Vice Chairman of the Board of Commissioners for a two year term were in order

Patrick G. Egros nominated Thomas G. Patterson for Vice President/Vice Chairman for a two-year term Ralph Jacoboni seconded the nomination

There being no further nominations, Temporary Chairman Beard declared nominations for this office of Vice President/Vice Chairman closed.

Being there was only one nominee, Secretary Beard declared a unanimous ballot for Thomas G Patterson as Vice President/Vice Chairman of the Board of Commissioners

At this time Temporary Chairman Beard turned over the chair to the newly elected President/Chairman of the Board of Commissioners, Nick Lorenzo

Chairman Lorenzo thanked the Commissioners for their vote of confidence to elect him to Chairman of the Commissioners. Chairman Lorenzo said without the four Commissioners along side him it would be hard to get things done. Chairman Lorenzo said the Township has good employees in Administration, Road Department and Police Department

Commissioner Sokol wanted to thank the Board of Commissioners and everyone around him for their support in reelecting him for another four (4) years. Commissioner Sokol said sitting in the audience is former Commissioners Martin and Temoshenka and Commissioner Sokol said he has learned a lot from them. Commissioner Sokol wanted to thank his wife for all the support she gives him.

Commissioner Iacoboni wanted to thank everyone who supported him in the election. Commissioner Iacoboni said he agreed with Chairman Lorenzo that we have a good Board and good employees.


