

**TOWNSHIP OF ROSTRAVER**  
**REORGANIZATION MEETING**

**January 4, 2010**

The Reorganizational Meeting of the Rostraver Township Board of Commissioners was called to order on this date by Secretary, Pamela S. Beard at 6:00 p.m. in the Rostraver Township Municipal Building.

Secretary Beard requested that newly elected Township Commissioners – Patrick G. Egros and Andrew S. Temoshenka to step forward to take the Oath of Office.

Secretary Beard continued that it was her privilege and extreme pleasure to introduce the Honorable Chris Scherer, Judge, who administered the Loyalty and Oaths of Office to the newly elected Commissioners Patrick G. Egros and Andrew S. Temoshenka.

Prior to Honorable Chris Scherer, Judge administering the Loyalty and Oaths of Office he wanted to say hello to everyone and thanked Magistrate Christner for allowing him to come today and today is his first day on the job and this will be the first official act and knows this community is in good hands with these men.

There being no further nominations, Temporary Chairman Beard declared nominations for this office of President/Chairman closed.

Being there was only one nominee, Secretary Beard declared a unanimous ballot for George A. Martin as President/Chairman of the Board of Commissioners

Temporary Chairman Beard declared nominations for the office of Vice President/Vice Chairman of the Board of Commissioners for a two year term were in order

Brian L. Sokol nominated Andrew S. Temoshenka for Vice President/Vice Chairman for a two-year term Nick Lorenzo seconded the nomination.

There being no further nominations, Temporary Chairman Beard declared nominations for this office of Vice President/Vice Chairman closed.

Being there was only one nominee, Secretary Beard declared a unanimous ballot for Andrew S. Temoshenka as Vice President/Vice Chairman of the Board of Commissioners.

At this time Temporary Chairman Beard turned over the chair to the newly elected President/Chairman of the Board of Commissioners, George A. Martin

Chairman Martin thanked the Board of Commissioners for there vote of confidence to elect him as Chairman and will do the best he can do the next two years.

Andrew S. Temoshenka moved that Timothy Maatta be named Solicitor to the Rostraver Township Board of Commissioners to serve for two years. Nick Lorenzo seconded the motion. The following yea and nay votes were recorded:

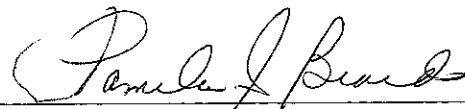
