WHEREAS, the Township of Rostraver had adopted certain fee schedules pursuant to Resolution 650 on August 7, 2002, Resolution 651 on September 4, 2002, Resolution 674 on July 2, 2003, Resolution 696 on July 7, 2004, Resolution 817 on April 2, 2008, Resolution 924 on September 21, 2011; Resolution 1005 adopted May 7, 2014; Resolution 1091 adopted August 2, 2017; and Resolution 1095 adopted November 1, 2017; Resolution 1185 adopted July 1, 2020; and

WHEREAS, the Board of Commissioners, Township of Rostraver, feels it is necessary to increase the fees on the following licenses to defray the costs of reviewing, processing, etc. such requests; and

WHEREAS, the Township of Rostraver has determined it would be in the public interest to amend said Resolution.


